Terms & Conditions

PAYMENT POLICY

- Schools Out Tours Inc. accepts tour payments in cash, cheque, money order, bank draft or via our online payment system, which is subject to a 3.9% processing fee.
- Regardless of the reason, should a tour be cancelled in writing by the group/client **45 days or more before the departure date**, Schools Out Tours Inc. will refund the payments you have made less the initial deposit and all expenses prepaid by Schools Out Tours Inc. such as airline tickets and event tickets. If the payments you have made at the time of cancellation, excluding the initial deposit, are less than the expenses prepaid by Schools Out Tours Inc., you will be responsible to pay the difference.
- Regardless of the reason, should the group/client cancel a tour in writing less than 45 days before the departure date, the entire amount you have paid is non-refundable. If the payments you have made at the time of cancellation are less than the "Total Tour Price" (see the Pricing section above) that you have been notified of by the date of your cancellation, you will be responsible for paying the difference.
- Tour payments cannot be refunded for passengers refused entry into any country within the tour. Travel documents are the responsibility of the individual travelers within the group.

PRICES

- Prices are subject to change for matters over which Schools Out Tours Inc. has no control, such as fuel surcharges, government taxes, airline schedule changes, foreign exchange rates and cancellations or price increases imposed by suppliers. You will be notified of said changes and the Total Tour Price will be re-calculated accordingly.
- The Total Tour Price is based on the number of participants, both paying and complimentary. **Should participant numbers change the Total Tour Price will be re-calculated accordingly.**
- Tour inclusions will be booked after the initial deposit is received and are subject to availability at the time of booking.

TOUR CHANGES

- Should the number of participants change, it may be necessary to revise components of the tour or adjust the cost to cover these differences.
- Schools Out Tours Inc. reserves the right to adjust the itinerary when necessary and would do so in consultation with the representative of the touring group.
- **45 DAYS BEFORE TRAVEL** - Requests for modifications to the itinerary or requests for changes to the number of travellers can no longer be accepted.

TRAVEL INSURANCE:
